**ORDINANCE PRESCRIBING THE FEES, OPERATING HOURS AND OTHER
CONDITIONS FOR THE USE OF PARKING SPACES OF THE MULTI-LEVEL
PARKING FACILITY**

WHEREAS, the City Government of Marikina operates and manages parking lots including a newly constructed multi-level parking facilities near the city hall;

WHEREAS, certainly parking spaces have high demands in a highly urbanized city like Marikina City due to influx of local tourists and visitors;

WHEREAS, the City Government of Marikina realizes the need to prescribe rental fees and charges for the use of such parking to ensure their effective management, repair and maintenance;

WHEREAS, Section 458 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides:

The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under section 22 of this Code, and shall:

(2) Generate and maximize the use of resources and revenues for the development plans, program objectives and priorities of the city as provided for under section 18 of this Code, with particular attention to agro-industrial development and citywide growth and progress, and relative thereto...

(3) Subject to the provisions of Book II of this Code, enact ordinances granting franchises and authorizing the issuance of permits or licenses, upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the city and pursuant to this legislative authority shall:

(i) Fix and impose reasonable fees and charges for all services rendered by the city government to private persons or entities;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD NG MARIKINA, in session duly assembled, that:

SECTION 1. Scope and Coverage. - This Ordinance shall cover the parking spaces of MULTI-LEVEL PARKING FACILITY near the City Hall.

SECTION 2. Regulation of Parking Fees and Operating Hours. - The following rates, fees and operating hours shall be imposed on the use of the parking space of the MULTI-LEVEL PARKING FACILITY:

PARKING HOURS:

5:00 AM to 9:00 PM – Mondays to Sundays, including Holidays

PARKING FEES:

For 4-wheeled motor vehicles, : ₱ 30.00 for the First 2 Hours
₱ 15.00 for every succeeding

hours

Parking will be on a "First Come First Served" basis and there will be **no reservations**.

SECTION 3. Lost Tickets. - Two Hundred Pesos (P200.00) shall be imposed for lost tickets.

SECTION 4. No Overnight Parking and Corresponding Penalty. - The Multi-level Parking Facility shall be closed at 9:00 pm. All parked vehicles beyond 9:00 pm may only be claimed the following day with the payment of penalty charge in the amount of Three Hundred Pesos (₱ 300.00) per day in addition to the regular parking fees as prescribed in the preceding section.

SECTION 5. Loss and Damages on Parked Vehicles. - The City Government shall not be held accountable for any loss of article(s) inside or outside a vehicle and/or damages thereof, regardless of amount or nature, while the vehicle is parked at the Multi-level Parking Facility.

SECTION 6. Prohibited Vehicles. - Trucks, heavy-tonnage vehicles, motorcycles, tricycles, tri-bikes, bicycles, e-bikes and other similar vehicles or mode of transportation shall not be allowed entry to park in the Multi-level Parking Facility.

SECTION 7. Issuance of Parking Tickets and Collection of Parking Fees. - The Office of the City Treasurer of Marikina shall assign personnel to issue parking tickets and collect parking fees.

SECTION 8. Maintenance of Parking Areas. - The Office of the City Engineer and the Building and Ground Maintenance Office shall undertake the maintenance and improvement of the Multi-level Parking Facility, including the lightings, markings, preparation and installation of required signages thereon.

SECTION 9. Exemptions. - Senior Citizens and Persons with Disabilities (PWDs) are exempted from payment of parking fees for the first two (2) hours. And on the third and the subsequent hours, the corresponding hourly rate shall already apply.


SECTION 10. Repealing Clause. - All ordinances, rules and regulations which are inconsistent with any provision of this Ordinance are hereby deemed repealed or modified accordingly.

SECTION 11. Separability Clause. - Any provision of this Ordinance not otherwise declared invalid by competent authority shall remain in full force and effect.


SECTION 12. Effectivity Clause. - This Ordinance shall take effect upon approval.
