ORDINANCE AMENDING SECTIONS 2 AND 3 OF ORDINANCE NO. 049, SERIES OF 2018 'AN ORDINANCE PROVIDING FOR THE INTEGRATION OF BARANGAY CLEARANCE FEE TO THE BUSINESS PERMITS AND LICENSING SYSTEM UNDER SEC. 11 OF R.A. NO. 11032 ALSO KNOWN AS EASE OF DOING BUSINESS AND EFFICIENT GOVERNMENT SERVICE DELIVERY ACT OF 2018'

WHEREAS, in order to fully implement and comply with the Republic Act 11032, those which states that:

SEC. 11. "(f) Barangay clearances and permits related to doing business shall be applied, issued and collected at the city/municipality in accordance with the prescribed processing time of this Act: Provided, that the share in the collections shall be remitted to the respective barangays."

NOW THEREFORE, BE IT OTDAINED AS IT IS HEREBY ORDAINED by the **SANGGUNIANG PANLUNGSOD** of **MARIKINA**, in session duly assembled that;

SECTION 1. Section 2 of the said ordinance should read as:

Section 2. Barangay Clearances and permit shall be applied, issued and collected by the Business Permits and Licensing Office.


SECTION 2. Section 3 of the said ordinance shall read as:

Section 3. To effect the one-time assessment of fees and charges and one-time payment, the barangay clearance fees shall be integrated by the city to its system and incorporated to its billing and Permit during renewal and application of new business, with rates based on Sec.1 and 2 of Ordinance No. 72 Series of 2011.

SECTION 3. This Ordinance shall take upon approval.
