**ORDINANCE PRESCRIBING THE RENTAL RATES FOR THE USE OF SPACE IN THE CHINESE PAGODA, HARDIN NG BAYAN, FREEDOM PARK, HAWKER'S STALL IN BARANGAY JESUS DELA PENA AND FVR ROAD, BARANGAY INDUSTRIAL VALLEY COMPLEX, THE RIVER BANK BIKE STATION AND OTHER SPACES IN MARIKINA HOTEL, SUBJECT TO EXISTING LAWS AND RULES AND REGULATIONS**

**WHEREAS**, in light of the reopening of the economy during this new normal, the City Government of Marikina recognizes the need for projects that can provide economic stimulus to small and medium scale businesses;

**WHEREAS**, the opening of commercial spaces owned by the City Government can provide adequate venues for commercial activities that could both benefit the public and the City;

**WHEREAS**, it was determined and recommended by the LGU Asset Management Committee the opening of the following areas that is commercially viable for leasing to private businesses, to wit- (1) Chinese Pagoda located in the Marikina River Park, Barangay. Sta. Elena; (2) Hardin ng Bayan located in the vicinity of Bayan Bayanan Avenue, Barangay Marikina Heights; (3) Hawker's Stalls in Barangay Jesus de la Pena and FVR Road, Barangay Industrial Valley Complex; (4) Bike Station in Marikina River Park, Barangay Sta. Elena and (5) other spaces in Marikina Hotel, such as the spaces in the cabana and lobby area;

**WHEREAS**, the City Government of Marikina realizes the need to prescribe rental fees and charges for the use of the space and other facilities of the commercial spaces to ensure the effective management, repair and maintenance thereof;

**WHEREAS**, after extensive deliberations, the rental rates for the commercial spaces were determined after considering the rental rates in the surrounding areas in consideration to the financial viability of the possible businesses that will operate therein;

**WHEREAS**, Section 458 of the Local Government Code provides;

*The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under section 22 of this Code, and shall:*

xxx

*(2) Generate and maximize the use of resources and revenues for the development plans, program objectives and priorities of the city as provided for under section 18 of this Code, with particular attention to agro-industrial development and citywide growth and progress, and relative thereto shall;*

*“(ii) xxx enact ordinances levying taxes, fees charges, prescribing the rates thereof for general and specific purpose, xxx ;*

*(3) Subject to the provisions of Book II of this Code, enact ordinances granting franchises and authorizing the issuance of permits or licenses, upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the city and pursuant to this legislative authority shall:*

*(i) Fix and impose reasonable fees and charges for all services rendered by the city government to private persons or entities*

**NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF MARIKINA** in a session duly assembled, that:

**SECTION 1.** The City Government hereby prescribes the rental rates and other fees and charges for the use of the following commercial spaces, to wit:
