**WHEREAS**, the Pamantasan ng Lungsod ng Marikina (PLMAR), through its President, Dr. Erico Habijan, endorsed Board Resolution No. 7, Series of 2023, entitled "*Resolution Formally Declaring And Establishing The PLMar Senior High School as a Laboratory School of the Pamantasan Ng Lungsod Ng Marikina*", herein attached as Annex and shall an integral part of this Ordinance;

**WHEREAS**, in the said endorsement, there is an urgent request in response to the recent guideline issued by the Department of Education (DepEd), through the Private Education Assistance Committee (PEAC), that all Senior High School Vouchers shall only be issued to Senior High Schools operated by Local Universities and Colleges (LUC) as a laboratory school.

**WHEREAS**, it is imperative that the PLMAR Senior High School (*PLMAR SHS*) is recognized as a Laboratory School to ensure that our Senior High School students will be eligible for these vouchers;

**WHEREAS**, failure to immediately pass a legislative measure establishing the PLMAR SHS as a Laboratory School will have severe consequences for its Senior High School students. The enrollment period is fast approaching, and without these vouchers, they may not be able to continue their education this year;

**WHEREAS**, the Sangguniang Panlungsod ng Marikina deems it necessary to adapt the above mentioned PLMAR Board Resolution and ordained the passage of the necessary legislative measure;

**WHEREAS**, Section 16 of the Local Government Code provides;

*General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.*

**WHEREAS**, Section 458 of the same Code provides;

*xxx that the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code xxx;*

**NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF MARIKINA** in session duly assembled, that:

**SECTION 1.** Declaring and Establishing the PLMAR Senior High School as a Laboratory School

PLMAR Senior High School is hereby declared and established as a LABORATORY SCHOOL of the Pamantasan ng Lungsod ng Marikina for the purpose of providing a practicum site for student teachers and venue for technical research for the College's undergraduate and graduate programs;

**SECTION 2. *Repealing Clause***

All Ordinances, executive orders, and administrative regulations, or part or parts thereof which are inconsistent with any of the provisions of this Code are hereby repealed or modified accordingly.

**SECTION 3. *Separability Clause.***

If any provision of this Ordinance shall be held as invalid or unconstitutional, any other provision hereof which is not affected thereby, shall continue to be valid and in full force and effect.

**SECTION 4. *Effectivity Clause.*** This Ordinance shall take effect upon its approval.




