ORDINANCE MODIFYING THE LIQUOR BAN IMPOSED IN  
MARIKINA CITY

**WHEREAS**, City Ordinance No. 040 Series of 2020 temporarily imposed a liquor ban in Marikina City for the duration of the Enhanced Community Quarantine (ECQ);

**WHEREAS**, due to the clamor of business establishments to be clarified regarding the prohibition especially to the pronouncement of the national government to leave this matter to the discretion of the Local Government Units;

**NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD of MARIKINA**, in session duly assembled, that:

**SECTION 1.** Regulation on the sale of liquor.- Sale of wine, beer, liquor and other alcoholic or intoxicating beverages in retail stores, supermarkets and other business establishments is allowed, however, drinking of such alcoholic beverages in any public place is strictly prohibited.


**SECTION 2.** Allowing liquor consumption at home and in private premises.- Alcoholic drinks and beverages purchased for consumption at home or in private premises shall be allowed provided that proper physical or social distancing shall be observed as mandated by national and city health authorities in order to avoid human to human transmission of COVID-19 in addition to what would be considered by IATF as "new normal practices" relative to liquor consumption.

**SECTION 3. *Repealing Clause.*** - This Ordinance hereby repeals Ordinance No. 040, Series of 2020 entitled "Ordinance imposing a temporary liquor ban in Marikina City during the Enhanced Community Quarantine."

**SECTION 4. *Effectivity.***- This Ordinance shall take effect starting May 16, 2020 and throughout of the Modified Enhanced Community Quarantine (Modified ECQ) period.

**UNANIMOUSLY ENACTED** by the **SANGGUNIANG PANLUNGSOD** of **MARIKINA**, this 13<sup>th</sup> day of May, 2020.


