ORDINANCE REPEALING ORDINANCE NO. 159, SERIES OF 2008 ENTITLED, "ORDINANCE AMENDING SECTIONS 57 AND 62 OF ORDINANCE NO. 133 SERIES OF 2006 ENTITLED ORDINANCE ADOPTING THE 2006 TRAFFIC MANAGEMENT CODE OF MARIKINA CITY" THUS REVERTING SECTIONS 57 AND 62 TO ITS ORIGINAL FORM

WHEREAS, on October 21, 2008, the City Council enacted Ordinance No. 159, Series of 2008 which provided for the amendment of Sections 57 and 62 of the 2006 Traffic Management Code of Marikina City;

WHEREAS, Section 57 provides for the "Designation of Parking Zones" while Section 62 provides for the "Overnight Parking";

WHEREAS, the amendment contained in Ordinance No. 159 Series of 2008 is for any medication in the designation of parking and overnight parking zones be subjected to the approval of the City Council by virtue of an Ordinance;

WHEREAS, however, the Office of Public Safety and Security has been continuously studying and monitoring the traffic flow in the City to provide ease and comfort to the constituents commuting to and from work;

WHEREAS, the original ordinance provides that the Head of the CTMDO (now OPSS), in coordination with concerned barangays and/or other offices/agencies of the City Government, is authorized to expand, reduce, amend or modify from time to time the list as he sees fit, subject to the approval of the City Mayor;

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that:

“Section 16. General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, x x x”

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD of MARIKINA, in session duly assembled, that:

SECTION 1. Ordinance No. 159, Series of 2008 entitled, “Ordinance Amending Sections 57 and 62 of Ordinance No. 133, Series of 2006 entitled Ordinance Adopting the 2006 Traffic Management Code of Marikina City” is hereby repealed.


SECTION 2. Effectivity – This Ordinance shall take effect immediately upon approval.


